- Plans, organizes, and conducts speaking engagements on various health education topics for community groups, schools, and professional organizations in Stephenson and Carroll Counties.
- Serves as a resource person to staff of both health departments and voluntary and official agencies to assure that a coordinated and effective health education component is incorporated in all services delivered to clients, patients, and the public.
- Coordinates ordering supplies and materials for health education programs.
- Plans, organizes, and assists other staff in organizing health promotion activities such as health fairs, health screenings, and similar events.

- Serves as program coordinator for initiatives such as colorectal cancer prevention, suicide prevention, tobacco/vaping control and education, health coaching, STD and teen pregnancy prevention, and other initiatives as assigned.
- Serves as public relations person for press releases, social media posts, interviews, and health literacy quality assurance.
- Participates and chairs various community coalitions as needed.
- Serves as consultant and resource for needs assessments, data collection analysis, and program evaluation techniques and practices.
- Develops, submits, and monitors grants and grant applications including budgets.
- Adheres to all grant reporting requirements.
- Assists with all health communication and health literacy practices.
- Participates as a member of senior staff.
- Assists with emergency, epidemic, and pandemic surveillance/response activities as necessary.
- Abides by and maintains the health departments HIPPA and privacy policies.
- Adhere to all internal SCHD policies and procedures.
- Performs other duties as required or assigned.
- Travel may be required as needed.
